


Enforcement & Monitoring Program Update

Strategic Planning Meeting November 7, 2013

Program Highlights

- Last time we met (February 2013)
 - A few white croaker found during recreational fishermen inspections
 - No white croaker at markets and restaurants
 - Field tested enforcement brochure
- Since February 2013:
 - The Enforcement brochure was finalized, printed, and distributed
 - Enforcement data analysis completed
 - White croaker landing assessment

Enforcement Brochure



- Positive feedback it is helpful and easy to understand
- It works for both markets and restaurants
- Focusing on white croaker helps avoid questions related to other fish




LA County Fish Vendors

- 48 market inspections
- White croaker observed on 1 inspection
- 92% of those asked were aware of the contamination



Long Beach and Orange County Commercial Fish Vendors

- 202 inspections 29% in Long Beach and 71% in Orange County
- No white croaker were identified
- On 45% of inspections, vendors reported being aware of the fish contamination issue





CDFW Recreational Fishing

- 102 inspection days analyzed
- On 86.3% of inspections days at least one angler reported awareness of the fish contamination issue



Signs (21%), warnings (20%), wardens (20%), and tip cards (19%).



CDFW Recreational Fishing

DNC Fish Observed and Seized:

- White croaker:
 - Observed in 57% (n=58) of the 102 inspection days.
 - 140 white croakers were seized on 5 inspection days; the numbers of fish seized were 2, 5, 7, 57, and 69.
 - White croaker related citations issued on 2 inspection days






Other DNC Fish Observed and Seized


Fish	% of inspection days when fish was observed	# Seized
Barred Sand Bass	49%	2 on 2 inspection days
Barracuda	17%	0
Topsmelt	23%	0
Black Croaker	6%	0

CDFW Commercial Fishing

- 50 total inspections:
 - Most inspections done at fish businesses,
 - 4% in vessels
 - 1 restaurant inspection
- Tip cards distributed on 33 of 50 inspections
- White croaker was observed on 1 of 50 inspections
- On 26 of 50 inspections, the entity operator was aware about the white croaker catch ban area



CDFW Commercial Fishing-Source of Catch Ban Info



CDFW – White Croaker Landings

- 2009: **3300 lb** of white croaker caught from the commercial catch ban area were landed
- 9/1/10 9/1/11: less than 68 lb of white croaker caught from the commercial catch ban area were landed
- 1/2012 3/2013:
 - 55 lb of white croaker (2 landings). It is not clear if the fish came from the catch ban area
 - 402 lb of white croaker (2 landings) offloaded in Long
 Beach, fisherman reported not fishing in catch ban area
